In the 2nd paragraph, change the 3rd line to read, "employee plus 2 or more dependents flexible benefit allowance was made available to everyone, even though it was not selected by everyone, in which case VCERA would have an unfunded benefit. This was because VCERA would be including a benefit valued at \$600-plus without having collected contributions for it; or if VCERA collected contributions for the larger amount, then the system would be collecting considerably more from employees with fewer than 2 dependents, and from the employer, than necessary."

Josiah Vencel was present on behalf of VCERA. Catherine Laveau was present on behalf of County of Ventura-Risk Management. The applicant, Allan P. Thin was not present.

Mr. Vencel read a statement from the applicant's spouse and then made summary remarks on the legal standards of permanently incapacity and on staff's recommendation.

Trustee Goulet said he understood that the County of Ventura objected to VCERA staff's recommendation that the applicant be granted a Nonservice-connected Disability Retirement.

Ms. Laveau said that while she appreciated VCERA's staff reconsideration of their initial recommendation for approval of the Service-connected Disability Retirement, the County disagreed that the applicant should be granted a Nonservice-connected Disability Retirement and believed both the Service-connected Disability Application and Nonservice-connected Disability Application should go to an evidentiary hearing.

Trustee Goulet then said that because the County had objected to the Nonservice-connected Disability Retirement case and because if the Board granted it, they could be subject to a Writ of Mandate. Since the Service-connected Disability Retirement case was going to go to a hearing regardless, he saw no reason to separate the two cases.

Chair Sedell remarked that he was not concerned that the Board could be taken to court because of an action they took, because that could happen with any action they took.

Ms. Webb provided an update on the status of Assembly Bill 826 (AB). She noted that AB 826 was now in an inactive status, which meant that it would not move forward in the 2021 legislative session. While staff was simply providing an informational update, she anticipated staff would bring a recommendation to the Board on September 27.

Shawn Atin, Human Resources Director, and Assistant County Executive Officer for County of Ventura, provided the following public comment on behalf of Mike Powers, Chief Executive Officer for the County of Ventura. He referenced a letter he distributed on Friday, September 10th regarding AB 826 to all of the trustees of the Board of Retirement and VCERA's administrative staff. He asked that the letter be put into the official record, including the attached letters from other stakeholders. He said the bill was placed on the inactive list at the request of the Governor's office for more time to discuss the bill with SEIU and the County of Ventura, with the goal of being considered in January 2022. Therefore, the County felt that any action on flexible benefit allowance at the time or in the near future by the Board of Retirement would be premature, at least until the next calendar year.

Chair Sedell requested that the letter and attachments from Mr. Powers be entered into the record.

Ms. Webb said that the letter and attachments would be placed on VCERA's website along with the minutes for the meeting.

X. STAFF COMMENT

Ms. Webb said that most of VCERA's staff was working remotely again as a result of the most recent health order, though staff members could work from the office if they chose to, as staff's workstations met the local health order requirements for working unmasked. She reminded the Board that several policies were overdue for review and she would then be sending the current versions to the Board members to obtain any feedback prior to formal presentation and review.

XI. BOARD MEMBER COMMENT

Trustee Hintz said that at the next Board meeting he would be proposing the Board receive a detailed account of VCERA's investments in companies based in the People's Republic of China. Further, if such a motion were passed, he would then move to bar future investments in companies based in China, as well as to direct the divestiture of existing investments in China, as reasonably appropriate. He said he was hopeful that one of the Board members who previously voted in favor of the

investment in Bain Capital's Special Situations Asia Fund II would move for reconsideration of that investment, as he was unable to because he had voted against it.

Trustee Goulet said that he had previously asked the other Board members to send him their comments and suggestions regarding the budget process for consideration at the next Finance Committee Meeting and had not received any comments thus far. He then said he had received notice that morning of a new Assembly Bill, which proposed to amend CERL Section 31461 which pertained to compensation earnable and appeared to make the action that the Board took to limit the flexible benefit allowance in the event that it is determined that it was appropriate to be included in compensation earnable moot. The bill was AB 498, which would be taken up next year by the Senate.

Trustee Long requested that staff provide a report on VCERA's investments by country and not just China, so that she could get an overall view of VCERA's investments.

Ms. Webb said that staff would make Trustee Long's request a part of Trustee Hintz's action item for the next agenda.
